CRIMINAL & TRAFFIC COST SCHEDULE**

Effective date: June 1, 2022

Pursuant to Ohio Traffic Rule 13, Criminal Rule 4.1 the following offenses shall not be processed by the Traffic Violations Bureau: in the following instances.

- 1. Any minor misdemeanor traffic offense in which an accident occurred that resulted in the injury to a person, where the violator can not verify the existence of proof of financial responsibility covering the operation of the vehicle at the time of the offense.**
- 2. If there are outstanding fines and / or costs due to the Court.**
